TERMS OF COMPETITION

1. ENTRIES

- a) By submitting an entry for The G4D Open (the "Championship") you are entering into an agreement with R&A Championships Limited (company number SC247047), having its registered office at Beach House, Golf Place, St Andrews, Fife KY16 9JA ("The R&A") and you agree to be bound by these Terms of Competition. It is the responsibility of each competitor to ensure they have read and comply with these Terms of Competition.
- b) The delivery of The G4D Open will be overseen by a committee comprised of representatives from The R&A and the DP World Tour ("The G4D Open Committee").
- c) The Championship shall be open to professional and amateur players who meet all of the following requirements:
 - (i) Players must hold a valid WR4GD pass with an eligible impairment from the list below:
 - Impaired Muscle Power
 - Impaired Passive Range of Movement
 - Limb Deficiency
 - Leg Length Difference
 - Short Stature
 - Hypertonia
 - Ataxia
 - Athetosis
 - Vision Impairment
 - Intellectual Impairment (II1, II2 and II3)

Players who need to obtain a WR4GD pass can apply via the EDGA website (edgagolf.com) which will require submission of any relevant medical information to support their application. Assessment can then be arranged with an EDGA Eligibility Assessor in their locality or on one of the UK Assessment days.

Players with a WR4GD pass but who have fluctuating conditions must have been reviewed by EDGA in the period between 1 January 2026 and close of entries.

Any player entering the Championship may be subject to review before their entry is accepted.

All entrants requiring a WR4GD pass to be confirmed and/or an assessment must have these finalised prior to close of entries.

- (ii) Players must be members of a golf club affiliated to a National Golf Association, authorised to adopt manage and maintain the World Handicap System™ (WHS) within their jurisdiction. *
- (iii) Players must hold a Handicap Index® of not more than 36.4 at date of entry, as issued by an Authorised Handicapping Body. Entrants who do not hold a Handicap Index® must hold a current equivalent exact handicap, as issued by a recognised Handicap Authority, that would demonstrate playing ability to a Handicap Index® of not more than 36.4 at date of entry. *

** Please note: The requirements of sections 1 (c) (ii) and 1 (c) (iii) do not apply to professional golfers. If you are a professional golfer who does not hold a handicap, you will be required to upload evidence of your professional status during the online entry process.*

- d) The Sport Class of each entrant will be confirmed by EDGA to The R&A at close of entries. The R&A and the DP World Tour have no involvement in the assignment of Sport Classes, which shall be the sole responsibility of EDGA.
- e) Entrants holding both a Handicap Index® and a handicap issued by a recognised Handicap Authority, must enter the Championship using their Handicap Index®. The penalty for failure to enter the Championship in compliance with this section 1 (e) is disqualification.
- f) The R&A may require independent certified evidence of the playing ability of entrants and it reserves the right to contact an entrant's current or previous golf club, National Golf Association or Federation to request their full handicap record for this purpose. An entry may be refused if, in the opinion of The G4D Open Committee, an entrant's Handicap Index® is not reflective of their playing ability.
- g) One entry per player must be submitted electronically via randa.org and must be received by close of entries i.e. 23:59hrs BST on Thursday 2 April 2026. Entries by telephone will not be accepted. It is the responsibility of the entrant to ensure that their online entry is completed successfully, and all contact details are accurate. Late entries will not be accepted. In the event of duplicate entries being submitted, the first entry will be used for all purposes. Duplicate entry fees that have been collected by The R&A will be refunded. Entry fees will be refunded if intimation of withdrawal is received on or before close of entries. After close of entries, entry fees will only be refunded to entrants who do not gain a place in the starting field. Any refund of entry fees will be processed within 28 days of the final day of the Championship to the card of original payment. If an entrant withdraws before or after close of entries, their withdrawal is final, and re-entry will not be permitted.
- h) Entrants may notify The R&A of any changes in handicap before close of entries by emailing amateurentries@randa.org. It is the responsibility of the entrant to ensure that any handicap changes have been received and subsequently adjusted prior to close of entries. The Handicap Index®/equivalent exact handicap at date of entry will be used for the purposes of determining the starting field and reserve list when applicable, except where an update of handicap has been notified to The R&A as described above. After close of entries, any subsequent handicap changes received will be disregarded.
- i) Acceptance of an online entry does not guarantee a place in the starting field. Entrants successful in gaining a place in the starting field will be advised after close of entries.
- j) All entries are subject to the approval of The R&A, which reserves the right to disqualify any person making a false statement in their online entry and/or to accept or refuse or, having accepted, subsequently reject any entry without giving reasons for its decision.
- k) A competitor must not make use of any drug to enhance performance. Should a competitor show clinical evidence of use of a drug for a nontherapeutic purpose, The G4D Open Committee may require the competitor to undergo a drug test. Any competitor found to be in breach of this section 1 (k) may be disqualified. Entrants who are taking medication and in doubt as to their clinical status should seek advice from The R&A or their National Anti-Doping Organisations.
- l) Where a competitor enters the Championship using their Central Database of Handicaps (CDH) number or unique identifier, their gender will be automatically populated in their online entry, based on the gender linked to their CDH number or unique identifier. Competitors who do not have a CDH number or unique identifier, or who choose not to enter using their CDH number or unique identifier, must select their gender in their online entry. Any transgender women or women with differences in sexual development (46 XY DSD) who wish to enter the Championship as a female are subject to The R&A's transgender and non-binary competition policy and must apply for pre-clearance from The R&A to compete in the Championship as a female. Application for pre-clearance must be made in writing to amateurentries@randa.org as early as possible and in no event not less than 6 weeks prior to the Championship. The R&A reserves the right to carry out a confidential case-by-case evaluation of whether any competitor's participation in the Championship, as a female, is likely to lead to unfair competition with other female competitors at any time either prior to, during or after the Championship if it determines that such an evaluation is or becomes necessary. The G4D Open Committee reserves the right to disqualify any competitor who makes a false statement in their online entry to the Championship, who does not comply with the requirements set out in The R&A's transgender and non-binary competition policy or where it determines that the competitor's participation in the Championship, as a female, would lead to unfair competition.

2. FORMAT

- a) The starting field will comprise a maximum of 80 competitors and played in 9 Sport Classes:
 - Standing 1 (St1)
 - Standing 2 (St2)
 - Standing 3 (St3)
 - Intellectual 1 (In1)
 - Intellectual 2 (In2)
 - Visual 1 (V1)
 - Visual 2 (V2)
 - Sitting 1 (Si1)
 - Sitting 2 (Si2)
- b) Any entrant named in the following categories will be allocated a place in the starting field of the Championship, subject to submitting an online entry on or before close of entries and meeting the eligibility criteria set out at section 1 (c) above.

- (i) Past overall winners of The G4D Open
- (ii) Sport Class winners (male and female) of The G4D Open 2025
- (iii) Winner of the G4D Tour Series Finale @ Rolex Grand Final (Gross) 2025
- (iv) Winners (male and female) of the Australia Victoria Open 2026
- (v) Winners (male and female) of the U.S. Adaptive Open 2025
- (vi) Winners (male and female) of the Japan Open for Golfers with Disability 2025
- (vii) The leading male and leading female in the South Africa Disabled Golf Association Order of Merit 2025 (Physically Disabled Gross)

Note: References to "Winner(s)" above is in the context of the Gross category.

- c) The G4D Open Committee reserves the right to exempt a player.
- d) The R&A will finalise the field after close of entries. Having allocated places to entrants under sections 2(b) and (c), places in the field will be allocated to ensure equitable representation in relation to gender and Sport Class, to the extent practicable and proportionate to the number of accepted entries. Thereafter, any remaining places in the field will be allocated as follows: (i) places in Sports Classes St1, St2, St3, In1 and In2 will be allocated in order of Gross WR4GD Ranking, Net WR4GD Ranking and Stableford WR4GD Ranking on calculation of WR4GD week 2026/13 (published on Wednesday 1 April 2026), then by handicap if necessary; and (ii) places in Sports Classes V1, V2, Si1 and Si2 will be allocated to ensure equitable representation of the Gross, Net and Stableford WR4GD Rankings on calculation of WR4GD week 2026/13 (published on Wednesday 1 April 2026) and by handicap if necessary. Unsuccessful entrants may be given the opportunity to compete in the event of withdrawals.
- e) Multiple sets of tees will be used ensuring the course length is appropriate for each Sport Class and gender.
- f) A competitor who fails to give The R&A notice of their withdrawal by close of registration or who is absent from the Championship without giving notice of their withdrawal will have their entry rejected for the next calendar year. Exceptions may be made in the case of sickness and other special circumstances at the discretion of The R&A. If an entrant withdraws before or after close of entries, their withdrawal is final, and re-entry is not permitted.
- g) Competitors must register no later than 12:00 hrs (midday) BST on the day prior to the first day of the Championship or they will be withdrawn.
- h) The Championship will be played in accordance with the Rules of Golf as approved by R&A Rules Limited and the Local Rules as approved by The G4D Open Committee.
- i) Model Local Rule G-12 is in effect. Under this MLR, a player or caddie must not use any written, printed, or electronic materials to help with reading the line of play for a stroke to be made from on the putting green. While any other use of a yardage book is allowed (such as a player making a note as to what club they used on an approach shot), to avoid any doubt a player should not look at their yardage book or any other material when the ball is on the putting green. If a player or caddie breach this Local Rule, they will receive a general penalty for the first breach and disqualification for the second breach.
- j) The Model Local Rule (MLR) in the Official Guide to the Rules of Golf is in effect regarding Conforming Driver Heads (MLR G-1).
- k) The G4D Open Committee will permit the use of motorised transportation by players holding a positive buggy indicator on their valid WR4GD pass. All other use of motorised transportation will be subject to the approval of The G4D Open Committee at its sole discretion.
- l) A copy of the Pace of Play Policy will be circulated electronically and will be available on request.
- m) The Championship will be decided by stroke play over 3 rounds. One round of 18 holes shall be played on each day. The groups and starting times for the first and second round shall be advised to competitors as soon as practicable after registration closes. After the second round there will be a cut to the following: Top 20 overall men and ties, top 10 overall women and ties, top 3 men in each Sport Class (if applicable) and top 2 women in each Sport Class (if applicable). The pairings and starting times for the final round shall be decided by The G4D Open Committee.
- n) In the event of a tie after 3 rounds, the winner of the Championship will be decided by a hole by hole play-off to take place immediately. Except in determining the winner of the Championship, all ties will be decided by card count back using the 18 hole 3rd round score (followed by last 9, 6, 3 or 1 of that round). If still a tie, the 18 hole 2nd round score (followed by last 9, 6, 3 or 1 of that round) will be used. If a tie still arises, the 18 hole 1st round score (followed by last 9, 6, 3, or 1 of that round) will be used. If no definitive outcome can be reached, The G4D Open Committee shall make a final decision.

3. PRIZES

The Champion may have played over any course length. There will be separate prizes for men and women.

- a) The winner will become The G4D Open Champion and will be awarded the Championship Trophy and a memento.
- b) The runner-up will receive a memento.
- c) The competitor in third place will receive a memento.

- d) The winners in each Sport Class listed in section 2 (a) above will receive a memento. All ties will be decided by card countback as per the principal set out in Section 2 (n) above.

4. GENERAL

- a) The R&A and the DP World Tour will not be liable for any loss, damage, cost or expense suffered by a competitor which was not reasonably foreseeable when participation was confirmed after the closing date, and/or was not directly caused by The R&A or the DP World Tour.
- b) The R&A and the DP World Tour will not be liable for any loss, damage, cost or expense suffered by a competitor as a result of a decision taken at any time by The G4D Open Committee to amend, curtail or cancel the Championship.
- c) Competitors are subject to all safety protocols applicable at the Championship in relation to Health & Safety as issued and updated by The G4D Open Committee and/or its safety advisers from time to time.
- d) All competitors are advised to have a personal public liability insurance policy in place to protect them from claims for damage to third party property or injury to third parties whilst participating in this Championship.
- e) All competitors are advised to have in place appropriate medical insurance and/or funding to cover routine medical and performance related healthcare such as musculoskeletal injuries, including outpatient investigation. This will include any competitors who may have travelled internationally and/or Federation Officials accompanying the competitor for the duration of their stay in the UK, in order that all such medical care is provided outside the NHS.
- f) Competitors must comply with any instructions or further guidance issued by The G4D Open Committee in relation to the Championship.
- g) The G4D Open Committee requires players and their team to conduct themselves in a manner that is respectful of the Championship and the sport of golf. Players and their team shall at all times act in the best interests of the sport and the Championship, and shall not conduct themselves in an unlawful or improper manner so as to bring the Championship, The R&A, the DP World Tour, the sport of golf or its governing bodies into disrepute and shall not use any one of or a combination of, violent conduct, threatening, abusive, indecent or insulting words or behaviour. Players and their team shall comply with any Code of Conduct set by The G4D Open Committee from time to time. For the purposes of this term, a player's team includes their caddies as well as any agents, coaches or other support team including family members present at the Championship or in the environs of the Championship venue or otherwise acting in relation to the Championship. If a competitor acts contrary to the spirit of the game, The G4D Open Committee will take appropriate action which may include reporting the facts to the competitor's Federation or National Golf Association. If the competitor is considered to have committed serious misconduct the competitor may be disqualified.
- h) All competitors are subject to the provisions of The R&A's Anti-Corruption and Betting Policy in force at the date of the Championship.
- i) All competitors and/or caddies are subject to the provisions of The R&A's Logos and Marks Policy in force at the date of the Championship.
- j) Any players gaining entry into the Championship who hold Russian and/or Belarussian nationalities and/or passports are subject to the Neutral Athlete Criteria set by the Committee from time to time.
- k) The G4D Open Committee seeks media coverage and publicity for The G4D Open around and during the Championship in the press and by live and recorded radio and television broadcasting and filming and on the internet. Each competitor by entering the Championship and thereby agreeing to these Terms of Competition assigns to The R&A and the DP World Tour and their respective assignees and licensees the right in perpetuity throughout the world to make, use, edit, exhibit and reproduce in any way now known or hereafter devised for commercial and/or other purposes from time to time and at their discretion, motion pictures, still pictures, live taped or filmed television, sound recordings and any other reproductions of any description of the competitor and/or their caddie (if applicable) made during or in connection with the Championship (including, without limitation, during practice and play) without compensation for the competitor or caddie or the heirs, successors, executors, administrators or assignees of the competitor or caddie. The competitor also irrevocably assigns to The R&A and the DP World Tour the right to use and reproduce, and to allow others to use and reproduce, the competitor and/or their caddie's name, image, voice, likeness, signature and biographical material in any way now known or hereafter devised, without compensation for the competitor or caddie or the heirs, successors, executors, administrators or assignees of the competitor or caddie including in circumstances where the name, image, voice, likeness, signature or biographical material: (i) is incorporated into any content or promotional material produced by The R&A or the DP World Tour or their respective sponsors or official suppliers, which may include the logo of a third party or of a sponsor or official supplier of the Championship or any subsequent Championship; or (ii) is used in relation to any other activities undertaken by The R&A and the DP World Tour. Competitors shall be responsible for ensuring that they hold all the necessary rights to grant the above assignments, including appropriate agreements with their caddies. The competitor shall release and discharge The R&A and the DP World Tour and their respective group companies, licensees, successors and assignees from any claims arising from use of their name, image, voice, likeness, signature and biographical material, including claims for misrepresentation of their character, or their person by any means. By entering the Championship and thereby agreeing to these Terms of Competition, the competitor hereby waives all privacy, publicity and proprietary rights. Notwithstanding the foregoing grant of rights, The R&A and the DP World Tour and their respective assignees and licensees agree that, other than as permitted above, they will not authorise any company contractually associated with The R&A or the DP World Tour to use the competitor's or caddie's

name, image, voice, likeness, signature and biographical material in a way which constitutes the endorsement of a product or service, without first requiring such associated company to first obtain the competitor's authorisation. The R&A may also use any image of the competitor taken at the Championship to populate the relevant pages of the WR4GD Rankings at wagr.com.

- l) All Championship information including a list of accepted entries may be viewed at www.randa.org.
- m) The G4D Open Committee's objective is to complete the Championship as per the format outlined in these Terms of Competition. The G4D Open Committee reserves the right to amend these Terms of Competition at any time before or during the Championship and/or to cancel the Championship before or during play. The decision of The G4D Open Committee is final in all matters.
- n) These Terms of Competition will be governed by and interpreted in accordance with the laws of Scotland.
